# **Executive Committee Reports**

# **Summer Conference Update (Drury)**

- Conference occurring at Marian University again
- Vendors will be moved to a different space to allow for more traffic
- Marian University Music Department is sponsoring the event so there is no cost for facilities
- \$1000.00 security fee
- Drury is considering other options for dining.
- Call for sessions already open and will be advertised in the coming *Notations*
- Headliners: Hilary Apfelstadt and Laura Farnell. Also looking into a Zoom session with Craig Hella Johnson
- Discussion ensues about issues with airfare for headliners. In the future, we may want to have a predetermined amount and timeline for determining airfare costs

# Treasurer's Report (Alles)

- Closed the Savings account because of new fees that the bank instituted
- Checking Account: Balance + Income = \$102,397.24
- Balance + Income subtracting expenses = \$82,476.55. There are still All-State bills to be paid. Currently, the All-State budget is on target.

#### **Ex-Officio and At-Large Reports**

All-State Jazz Choir (Buchanan, presented earlier in the meeting)

- Reviewing the 2022 All-State Vocal Jazz Choir:
  - \$1000.00 housing deposit was made but was not reimbursed until Buchanan had asked for it back

- There were some unexpected expenses with meals and service charges. These charges are reflected in the 2023 Vocal Jazz Choir budget.
- Buchanan will not be at the 2023 conference, but Mark Yount will be helping in her place
- Buchanan is considering using a different audition app next year instead of HeartOut. Submittable is the app that ACDA uses.
- No airfare will be needed for the All-State Jazz director, Matt Falker
- Borns asks about getting a sponsor for the event to offset the costs for students. Suggestions: colleges, Sweetwater, travel companies.
- Motion to approve the 2023 Vocal Jazz Choir Budget: Drury, Miller. Approved.

# All-State Choir (Hummel reports on behalf of Anissa Bradley and Brian Adcock)

- Bradley is absent due to illness and Adcock is handling All-State Choir
- Lane Velayo would like feedback about the All-State Choir
- The choir's hotel is Holiday Inn and rehearsals are at Purdue-Ft. Wayne in the International Ballroom
- Glann proposes to pay Adcock a stipend (same as last year) for handling the work this year. Motion: Glann, Borns. Approved

#### **Notations** (Dean)

- Postage is expensive. Dean is talking with ACDA national about their bulk postage permit.
- The Winter issue has been mailed
- Next year, Dean would like to switch to a digital newsletter instead of printing
  - Currently printing and mailing costs \$850.00
  - Dean would like to add a question during membership renewal allowing people to opt-in to receive printed *Notations* and pay an extra \$3.00. Glann suggests instead to use the same list of people who would want the ACDA national magazine publication. Dean will look into this more.

# **IMEA Liaison Report** (Hummel)

- March deadline for session proposals and call for performances for next year's IMEA Conference
- Encourages representation of ICDA groups at the IMEA conference
- Asks for feedback about this year's conference and ideas for headliners that are choir-focused
- Drury suggests doing a social event at the IMEA conference

# **ICDA Membership Coordinator** (Hummel)

- The position needs to be added to the Policy Log (the document created by Glann as a repository of information to be communicated to future leadership). The secretary should add any updates.

# **ACDA Quarterly Allotment** (Hummel)

- ACDA bases this amount on active membership from April 1 every year.
- Glann encourages a membership push before April 1. People often renew membership with their conference registration

### **District reports**

- Arroyo would like to do a district-wide meet-and-greet, and asks if there is money in the budget to help cover the costs. This is not included in the budget now and if it were, it would need to be available for all of the districts. Kavanagh held a similar event at a restaurant and it did not involve any costs from her end.
- Saureland asks about responsibilities for All-State Choir area leaders. Contact Anissa Bradley.
- Kavanagh is sending reminders to her district about the ACDA conference
- Miller is contacting people to come to the conference and join ICDA

# **Repertoire and Resources Coordinator Reports**

- Borns has replaced Dan Andersen's position as the Youth Coordinator.
- Hampton would like to have a directory of community choirs. Kitzmiller has possible connections with that resource.
- Stone wants certain repertoire on the middle school ISSMA list that conflict with rules about unison parts. Discussion ensues about addressing rule changes and other concerns with ISSMA.
- Stone and Kitzmiller will head a taskforce to address the specific ISSMA rule regarding the number of parts in middle school repertoire

Hummel will send a form to get feedback about the meal and location of this meeting.
